**Subject:- Disposal of condemned Government vehicles-reg.**


Office of the Commissioner, CGST & CX., Ahmedabad North Commissionerate, Ahmedabad is proposing to dispose of 02(two) Government vehicles on "as is where is basis". Details of the said vehicles are as under:-

2. Accordingly, sealed quotations are invited for the disposal of the said vehicles on the terms and conditions mentioned below, Persons/firms, interested in purchasing the above mentioned vehicles, may submit the quotations in the enclosed Proforma in a sealed cover addressed to the undersigned latest by **17:00 hrs** on or before **03.09.2021** at **O/o Commissioner, CGST & CX., Ahmedabad North, 1<sup>st</sup> Floor, Custom House, Near All India Radio, Income Tax Circle, Ashram Road , Navrangpura, Ahmedabad**. The quotations received in time will be opened at **15:30 hrs. on 06<sup>th</sup> September, 2021**. The representatives of the bidders, if they desire, may be present (not more than one representative for each quotation) at the time of opening the quotations. The cover should be prominently superscripted with the words "**QUOTATION FOR PURCHASE OF CONDEMNED VEHICLE.**"
3. The vehicles will be available for inspection between **18.08.2021 to 03.09.2021** in the presence of the GSO/PRO, CGST & CX., Ahmedabad North.
4. The auction of the said vehicles will be governed by the following conditions:-
  - (i) Each vehicle will be auctioned separately not through the lot.
  - (ii) The vehicles will be sold on "As is where is" basis. The auction process will be conducted in presence of Disposal of Goods Committee.
  - (iii) The bidders are required to pay Earnest Money of **Rs. 5,000/- (Rupees Five Thousand only)** for each above vehicles.
  - (iv) Earnest money is payable by means of Demand Draft drawn in favour of **Pay & Account Office, CBEC, Ahmedabad**.
  - (v) Quotations received without demand draft towards Earnest Money will not be considered and shall be rejected.
  - (vi) The successful bidder will be required to deposit the bid amount by means of Demand Draft drawn in favour of the "**Pay & Accounts Office, CBEC, Ahmedabad**" within 02 (two) working days of the acceptance of bid.
  - (vii) The Earnest Money of the successful bidder will be released only after the deposit of the bid amount. Earnest Money will be adjusted as bid amount and will be forfeited, if he fails to honour the bid. In case of failure to deposit final bidding amount, the respective vehicle may once again taken for re-auction.
  - (viii) The delivery of the auctioned vehicles will be arranged only after the successful bidder submits documentary evidence in support of residential status(PAN Card, Aadhar Card etc. in case of individual and Registration Certificate etc. in case of firms).

- (ix) The auctioned vehicles will be removed by the successful bidder within 02 working days of depositing the bid amount, at their own expense.
- (x) The vehicles will be disposed off on "as is where is" basis and no guarantee for its worthiness or quality will be given by this Department.
- (xi) **The successful bidder has to scrap the vehicle and submit the cut part of the chassis number to this office immediately.**
- (xii) The bidder will not be allowed to withdraw their bids and if they do so their earnest money will be forfeited.
- (xiii) **The Bid amount is excluding GST, as the GST is to be paid by the recipient of the goods as per the rates applicable.**
- (xiv) The undersigned reserves the right to accept or reject any/all of the quotations without assigning any reason.
