Corrigendum to Order-In-Appeal No. AHM/EXCUS-002-APP-131/23-24 dated 30.10.2023 passed in the case of M/s. Josh Derma Care Pvt. Ltd.

4. The name and address of the Appellant mentioned at the last Page (Page No.10) of the said OIA,

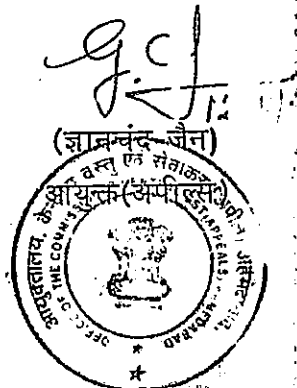
may be read as
