Please refer the Order-in-Original No. 92/ADC/GB/2021-22_Dated 21.03.2022 issued by Additional Commissioner C.Ex. and CGST, Ahmedabad North

2. Para 24(3) at page 6 of the said OIO may be read as following:

(3) I impose penalty of Rs. 61,42,669/- under section 78 of the Finance Act, 1994, as amended. I further order that in terms of Section 78(1) of the Finance Act. 1994 if M/s Khevna Infrastructure, pays the amount of Service Tax as determined at Sl. No.(1) above and interest payable thereon at (2) above within thirty days of the date of communication of this order, the amount of penalty liable to be paid by M/s Khevna Infrastructure, shall be twenty-five percent of the penalty imposed subject to the condition that such reduced penalty is also paid within period so specified.
