

BRIEF FACTS OF THE CASE:

M/s Manji Kalyanji Vekariya having their principal place of business at A-2, Rahul partment, Naranpura Gam, Naranpura, Ahmedabad, Gujarat-380013 (here nafter referred to as "M/s. Manji" for sake of brevity) are engaged in the supply various taxable goods and they are registered with the department laving GSTIN 24AIFPV3416N1ZX and falls under the jurisdiction of Central GST & Central Excise, Ahmedabad North Commissionerate.

- The Directorate General of Analytics & Risk Management, New Delhi vide report 49D issued from F.No.DGARM/TT/BIA/RTP 2022-NTCP dated 06.10.2022, nad informed that M/s. Manji is indulged in violating of Rule 96(10) of CG-T Rules, 2017 by way of getting refund of IGST on export of their goods which were originally procured as merchant exporter at the concessional rate of tax under Notification No.40/2017-CT(R) or 41/2017-IT(R) both dated 23.10.2017. Rule 96(10) of CGST Rules, 2017 provides an express debar to IGST refunds in case the exporter has received inward supplies where benefits of any of these notifications have been availed.
 - 2.1. The details of such refunds as provided under the DGARM Report No. 49D are as per the table given below:

- 3. An inquiry was initiated against M/s Manji and since they appeared to have availed he benefit of the above said notifications during the period from 23.10.2017 to 31.03.2022, details of exports made by them during the said period were alled for under letter bearing F.NO.CGST/WT0701/DGARM-49-A,B,C,D/26/ 1022-23 dated 28.03.2023 and 28.03.2023 subsequent reminder issued under F.No.CGT/WT0701/DGARM-49D/Manji/26/2023 dated 20.04.2023 but M/s. Manji had not submitted the required details which were called for under the above said letters.
- 4. Relevant provisions of GST Law:-
- 4.1. The Provisions of Rule 96(10) of CGST Rules, 2017 are as under:

"RULE 96. Refund of integrated tax paid on goods [or services] exported out of India:(1).
(2).

- "(10) The persons claiming refund of integrated tax paid on exports of good; or services should not have –
- (a) received supplies on which the benefit of the Government of India, Ministry of Finance notification No. 48/2017-Central Tax, dated he 18th October, 2017, published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (i), vide number G.S.R. 1805(E), dated the 18th October, 2017 except so far it relates to receipt of capital goods by such person against Export Promotion Capital Goods Scheme or notification No. 40/2017-Central Tax (Rate), dated the 23rd October, 2017, published in the Gazette of India,

Extraordinary, Part II, Section 3, Sub-section (i), vide number G.S.R. 1320(E), dated the 23rd October, 2017 or notification No. 41/2017-Integrated Tax (Rate), dated the 23rd October, 2017, published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (i), vide number G.S.R. 1321(E), dated the 23rd October, 2017 has been availed; or

- (b) availed the benefit under notification No. 78/2017-Customs, dated the 13th October, 2017, published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (i), vide number G.S.R. 1272(E), dated the 13th October, 2017 or notification No. 7c/2017-Customs, dated the 13th October, 2017, published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (i), vide number G.S.R. 1299(E), dated the 13th October, 2017 except so far it relates to receipt of capital goods by such person against Export Promotion Capital Goods Scheme.]"
- 4.2. From the plain reading of above provision, it can be construed that Rule 96 of the CGST Rules, 2017 deals with the procedure for refund of taxes paid on export of goods and services. Rule 96 (10) restricts the eligibility to elaim refund of taxes paid on export in those cases where the merchant exporter has received goods to be exported at the concessional/reduced rate of tax under Notification No.40/2017-Central Tax (Rate) or 41/2017-Integrated Tax (Rate) both dated 23.10.2017 notified under sub-rule (10) of Rule 96 of the said rules.

This restriction was first introduced vide Notification No. 03/2018-Central Tax dated 23.01.2018, which got subsequently modified and amended by way of Notifications issued from time to time (as discussed below).

Notification No. 03/201 8-Central Tax dated 23.01.2018 reads as:-

"(x) with effect from 23rd October, 2017, in rule 96,

"(10) The persons claiming refund of integrated tax paid on exports of goods or services should not have received supplies on which the supplier has availed the benefit of the Government of India, Ministry of Finance, notification No. 48/2017Central Tax dated the 18th October, 2017 published in the Gazette of India, Extraordinary, Part II, Section 3, Subsection (i), vide number G.S.R 1305 (E) dated the 18th October, 2017 or notification No. 40/2017-Central Tax (Rate) 23rd October, 2017 published in the Gazette of India, Extraordinary, Part II, Section, 3 Sub-section (i), vide number G.S.R 1320 (E) dated the 23rd October, 2017 or any notification No. 41/2017-Integrated Tax (Rate) dated the 23rd October, 20)7 published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (i), vide number G.S.R 1321 (E) dated the 23rd Cotober, 2017 or notification No, 78/2017-Customs dated the 13th October, 2017 published in the Gazette of India, Extraordinary, Part II, Section 3, Subsection (i), vide number G.S.R 1272(E) dated the 13th October, 2017 or notification No. 79/201 7-Customs dated the 13th October, 2017 published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (i), vide number G.S.R 1299 (E) dated the 13th October, 2017."

The above notification says that person claiming refund of IGST parexports of goods or services should not have received supplies on which supplier has availed the benefit of Notifications as mentioned therein.

4.3. Vide Natification No. 39/2018-Central Tax dated 04.09.2018, the said Rule 96(10) of CGST Rules, 2017 was further amended as below:-

"6.In the said rules, with effect from the 23rd October, 2017, in rule 96, for sub-rule (10), the following sub-rule shall be substituted, namely:-

(10) Th persons claiming refund of integrated tax paid on exports of goods or services should not have –

(a) received supplies on which the benefit of the Government of India, Ministry of Finance notification No. 48/2017-Central Tax, dated the 18th October 2017 published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (i), vide number G.S.R 1305 (E), dated the 18th October 2017 or notification No. 40/2017-Central Tax (Rate), dated the 23rd October, 2017 published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (i), vide number G.S.R 1320 (E), dated the 23rd October, 2017 published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (i), vide number G.S.R 1321 (E), dated the 23rd October 2017 has been availed; or

(b) availed the benefit under notification No. 78/2017-Customs, dated the 13th O tober, 2017 published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (i), vide number G.S.R 1272(E), dated the 13th October 2017 or notification No. 79/2017-Customs, dated the 13th October 2017 published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (i), vide number G.S.R 1299 (E), dated the 13th October 2017."

Thus, from the perusal of above notification, it can be construed that refund on exports cannot be availed by the exporter if the inputs/finished goods procued by them have enjoyed benefits of certain notifications mentioned therein in the Rule 96(10) including the Advance Authorization benefits with etrospective effect from 23.10.2017.

Further, vide Notification No. 53/2018-Central Tax dated 09.10.2018, the Rule 96(10) was further amended with effect from 23.10.2017 which reads as:-

- "1. (1) These rules may be called the Central Goods and Services Tax (Eleven h Amendment) Rules, 2018.
- (2) The ishall be deemed to have come into force with effect from the 23rd October 2017.
- 2. In the Central Goods and Services Tax Rules, 2017, in rule 96, for subrule (10), the following sub-rule shall be substituted and shall be deemed to have been substituted with effect from the 23rd October, 2017, namely:-

"(10) The persons claiming refund of integrated tax, paid on exports of goods or services should not have received supplies on which the supplier has av tiled the benefit of the Government of India, Ministry of Finance, notification No. 48/2017-Central Tax, dated the 18th October, 2017, published in the Gazette of India, Extraordinary, Part II, Section 3, Subsection (i), vide number G.S.R 1305 (E), dated the 18th October, 2017 or notification No. 40/2017-Central Tax (Rate) dated the 23rd October, 2017, published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-

section (i), vide number G.S.R 1320 (E), dated the 23rd October, 2017 or notification No. 41/2017-Integrated Tax (Rate), dated the 23rd October, 2017, published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (i), vide number G.S.R 1321 (E), dated the 23rd October, 2017 or notification No. 78/2017-Customs, dated the 13th October, 2017, published in the Gazette of India, Extraordinary, Part II, Section 3, Subsection (i), vide number G.S.R 1272(E), dated the 13th October, 2017 or notification No. 79/2017- Customs, dated the 13th October, 2017, published in the Gazette of India, Extraordinary, Part II, Section 3, Subsection (i), vide number G.S.R 1299 (E) dated the 13th October, 2017."

Thus, from the perusal of above notification, it can be obserted that subclause (a) and (b) of sub-rule 10 of Rule 96 are merged and this notification has been also made effective from 23.10.2017. It says that person claiming refund of IGST paid on exports of goods or services should not have received supplies on which the supplier has availed the benefit of Notifications as mentioned therein.

In the instant case, the taxpayer appeared to have procured finished goods at the concessional rate of tax from the suppliers availing benefits under Notification No. 40/2017-CT(R) or 41/2017- IT(R) both dated 23.10.2017 & thereafter, these finished goods were exported on payment of IGST refund was claimed of such IGST paid. The said mechanism adopted by taxpayer is restricted under GST law as discussed above.

5. Outcome of Inquiry:

Since M/s. Manji had failed in furnishing the required information called for by the department as discussed above despite repeated reminders, it was not possible to quantify the actual amount of refund taken by them by procuring such finished goods at the concessional rate from the suppliers availing exemption of reduced rate of tax on such outward supply under Notification No. 40/2017-CT(R) or 41/2017- IT(R) both dated 23.10.2017 discussed here-in-above, no option was left except to rely upon figures/data provided by DGARM under Report No.49D as detailed in the table appearing at Para No.2.1 above.

5.1. From the inquiry of case, the following facts have emerged:

The Taxpayer appeared to have availed the double benefit, one at the time of procuring finished goods for export purpose as merchant exporter at the concessional rate of tax from the suppliers availing benefits of No ification No. 40/2017-CT(R) or 41/2017- IT(R) both dated 23.10.2017 and on the other hand by claiming the refund on the exports made on payment of IGST in terms of Rule 96 of Central Goods and Services Tax Rules, 2017 as mentioned above.

However, as per the provisions of Rule 96(10) of CGST Rules, the taxpayer can avail either refund of IGST paid on goods exported or exemption of tax on the goods procured at the concessional rate of tax under Notification No. 40/2017-CT(R) or 41/2017-IT(R) both dated 23.10.2017. Further export of such goods should be made without payment of IGST and even if IGST has been paid on such merchant export no refund of such IGST paid suo-moto by the merchant exporter can be claimed under the provisions of Rule 96(10) of GST Rules, to compare the provision of Rule 96(10) of GST Rules, to compare the provision of tax is availed on the input nuterials and the stands prohibited and vice versa.

6. QUANTIFICATION OF GST:

6.1 As no details were submitted by M/s. Manji till the time of issuance of SCN, the total amount of IGST refund taken to the tune of Rs.4,48,00,000/-appeared to have been taken on exports of goods procured at the concessional rate of tax from the suppliers availing benefits of reduced rate of tax on such outward supplies under Notification no.40/2017-CT(R) or 41/2017-IT(R) both dated 23.10 2017, which was contrary to and inadmissible under the provisions of Rule 96(10) of the CGST Rules, 2017.

6.2 Thus, the amount of Rs.4,48,00,000/- of IGST Refund on the goods exported by the taxpayer which were originally procured from the suppliers availing benefits of the concessional rate of tax under Notification No.40/2017-CT(R) or 41/2017-IT(R) both dated 23.10.2017 on such supplies, is required to be demanded and recovered from the taxpayer under the provisions of Section 74(1) of the CGSTAct 2017.

7. LEGAL PROVISIONS:

7.1 Following are the relevant provisions applicable for payment of GST by the Taxpayer: -

7.1.1 Cross empowerment of Central Tax/CGST officers:

The Government has authorized officers of CGST as well as SGST as proper officer under Section 6 of CGST Act 2017. Section 6 of Gujarat Goods and Services Tax Act, 2017 also deals with such authorization. The relevant portions of the said Acts are reproduced hereunder for ease of reference:

(A) Section 6 of CGST Act 2017:

- "6. (1) Without prejudice to the provisions of this Act, the officers appointed under the State Goods and Services Tax Act or the Union Territory Goods and Services Tax Act are authorized to be the proper officers for the purposes of this Act, subject to such conditions as the Government shall, on the recommendations of the Council, by notification, specify.
- (2) Subject to the conditions specified in the notification issued under sub-section (1),-
- (a) where any proper officer issues an order under this Act, he shall also issue an order under the State Goods and Services Tax Act or the Union Territory Goods and Services Tax Act, as authorised by the State Goods and Services Tax Act or the Union Territory Goods and Services Tax Act or the Union Territory Goods and Services Tax Act, as the case may be, under intimation to the jurisdictional officer of State tax or Union territory tax;
- (b) where a proper officer under the State Goods and Services
 Tax Act or the Union Territory Goods and Services Tax Act has
 initiated any proceedings on a subject matter, no proceedings
 shall be initiated by the proper officer under this Act on the

same subject matter.

- (3) Any proceedings for rectification, appeal and revision, wherever applicable, of any order passed by an officer appointed under this Act shall not lie before anofficer appointed under the State Goods and Services Tax Act of the Union Territory Goods and Services Tax Act.
- (B) Section 6 of SGST Act 2017:
 - "6. (1) Without prejudice to the provisions of this Act the officers appointed under the Central Goods and Services ax Act are authorized to be the proper officers for the purposes of this Act, subject to such conditions as the Government shall, on the recommendations of the Council, by notification, specify.
 - (2) Subject to the conditions specified in the notification issued under sub-section (1),
 - (a) where any proper officer issues an order under this Act, he shall also issue an order under the Central Goods and Services Tax Act, as authorised by the said Act under intimation to the jurisdictional officer of central tax;
 - (b) where a proper officer under the Central Goods and Services Tax Act has initiated any proceedings on a subject matter, no proceedings shall be initiated by the proper officer under this Act on the same subject matter.
 - (3) Any proceedings for rectification, appeal and revision, wherever applicable, of any order passed by an officer appointed under this Act, shall not lie before an officer appointed under the Central Goods and Services Tax Act. "
- 7.1.2 Thus, from the above, it is clear that the officers of Central Tax as well as officer of State Tax, both are the Proper Officer for the purpose of Section 6 of CGST Act as well as SGST Act and any of them can initiate any proceeding under this Act.
- 7.2 Section 54 of Central Goods and Services Tax Act, 2017:-Section 54 of the CGST Act, 2017 provides for provision with respect of Refund. Section 54(8) of the CGST Act, 2017 states with regard to refund on export good that:
 - "(8) Notwithstanding anything contained in sub-section (5), the refundable amount shall, instead of being credited to the Fund, be paid to the applicant, if such amount is relatable to-
 - (a) refund of tax paid on zero-rated supplies of goods or services or both or on inputs or input services used in making such zero-rated supplies; "
- 7.3 Section 16 of Integrated Goods and Services Tax act.
 2017:- This provision of law provide for refund of tax, accumulated on account of Zero rate supply or paid on effecting zero rated supply.

The provision states that:

- (1) "zero rated supply" means any of the following supplies of goods or services or both, namely: -
- (a) expert of goods or services or both; or
- (b) supply of goods or services or both to a Special Economic Zone developer or a Special Economic Zone unit.
- (2) Subject to the provisions of sub-section (5) of section 17 of the Central Goods and Services Tax Act, credit of input tax may be availed for making zero-rated supplies, notwithstanding that such supply may be an exempt supply.
- (3) A registered person making zero rated supply shall be eligible to claim refund under either of the following options, namely:-
- (a) he may supply goods or services or both under bond or Letter of Undertaking, subject to such conditions, safeguards and procedure as may be prescribed, without payment of integrated tax and claim refund if unutilised input tax credit; or
- (b) he may supply goods or services or both, subject to such conditions, safeguards and procedure as may be prescribed, on payment of integrated tax and claim refund of such tax paid on goods or services or both supplied,

in accordance with the provisions of section 54 of the Central Goods and Services Tax Act or the rules made thereunder.

7.4 Rule 96(10) of the CGST Rules 2017

As per Rule 96(10) of the CGST rules, 2017 the taxpayer availing refund of IGST paid on Zero rated Outward Supplies should not have availed the benefit of Notification No.48/2017-Central Tax dated 18th October, 2017 or78/2017-Cus or 79/2017-Cus both dated 13.10.2017.

"96. Refund of integrated tax paid on goods or services exported out of India: -

- "(10) The persons claiming refund of integrated tax paid on exports of goods of services should not have –
- (a) received supplies on which the benefit of the Government of India, Ministry of Finance notification No.48/2017-Central Tax, dated the 2017, published in theGazette of 18thOctober, Extraordinary, Part II, Section 3, Sub-section (i), vide number G.S.R 1305 (B) dated the 18thOctober, 2017 except so far it relates to receipt of capital goods by such person against Export Promotion Capital Goods Scheme or notification No. 40/2017-Central Tax Rate), dated the 23rdOctober, 2017, published in the Gazette of hdia, Extraordinary, Part II, Section 3, Sub-section (i), vide number G.S.R 1320 (E), dated the 23rdOctober, 2017 or notification No. 41/2017-Integrated dated the23rdOctober, Tax (Rate),

2017, published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (i), vide number G.S.R 1321 (E), dated the 23rdOctober, 2017 has been availed; or

(b) availed the benefit under notification No. 78/2017-Customs, dated the 13thOctober, 2017, published in the Gazette of India; Extraordinary, Part II, Section 3, Sub-section (i), vide number G.S.R 1272(E), dated the 13thOctober, 2017 or notification No. 79/2017-Customs, dated the 13thOctober, 2017, published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (i), vide number G.S.R 1299 (E), dated the 13thOctober 2017 except so far it relates to receipt of capital goods by such person against Export Promotion Capital Goods Scheme.

Further, as per the Notification No.16/2020-CT dated 23 03.2020 an amendment has been made by inserting following explanation to Rule 96(10) of CGST Rules, 2017 as amended (With retrospective effect from 23.10.2017).

"Explanation.- For the purpose of this sub-rule, the benefit of the notifications mentioned therein shall not be considered to have been availed only where the registered person has paid Integrated Goods and Services Tax and Compensation Cess on inputs and has availed exemption of only Basic Customs Duty (BCD) under the said notifications."

By virtue of the above amendment, the option of claiming refund under option as per clause (b) is restricted to the exporters who only avails BCD exemption and pays IGST on the Raw materials.

Sec. 59 of CGST Act, 2017

The Government had introduced self-assessment system under a trust-based regime which casts the onus of proper assessment and discharging of the tax on the taxpayer. Section 59 of the Central Goods and Services Tax Act, 2017 provides that every registered person shall self-assess the taxes payable under this Act. Thus, it appears that the taxpayer had failed to self-assess the eligibility of the refund thereby contributing the provisions of Section 59 of the Central Goods and Service Tax Act, 2017.

Sec. 39(7) of CGST Act 2017

[(7) Every registered person who is required to furnish a return under subsection (1), other than the person referred to in the proviso the eto, or subsection (3) or sub-section (5), shall pay to the Government that tax due as per such return not later than the last date on which he is required to furnish such return:

Provided that every registered person furnishing return under the proviso to sub-section (1) shall pay to the Government, the tax due taking into account inward and outward supplies of goods or services or both, input tax credit availed, tax payable and such other particulars during a month, in such form and manner, and within such time, as may be prescribed.

Provided further that every registered person furnishing return under section (2) shall pay to the Government, the tax due taking into ac

turnover in the State or Union territory, inward supplies of goods or services or both, tax payable, and such other particulars during a quarter, in such form and manner, and within such time, as may be prescribed.

Sec. 39(9) of CGST Act 2017

Section 39(9) of the Central Goods and Service Tax Act, 2017 provides

Subject to the provisions of sections 37 and 38, if any registered person after furnishing a return under sub-section (1) or sub-section (2) or subsection (3) or sub-section (4) or sub-section (5) discovers any omission or incorrect particulars therein, other than as a result of scrutiny, audit, is spection or inforcement activity by the tax authorities, he shall rectify such omission or incorrect particulars in the return to be furnished for the month or quarter during which such omission or incorrect particulars are oticed, subject to payment of interest under this Act;

Provided that to such rectification of any omission or incorrect particulars hall be allowed after the due date for furnishing of return for the month of September or second quarter fallowing the end of the financial year, or the actual date of furnishing of relevant annual return, whichever is earlier."

7.5.Determination of tax not paid or short paid or erroneously refunded or input tax credit wrongly availed or utilized by reason of fraud or any willful misstatement or suppression of facts.

"Section 74 (1) Where it appears to the proper officer that any tax has not been paid of short paid or erroneously refunded or where input tax credit has been wrongly availed or utilized by reason of fraud, or any willful-misstatement or suppression offacts to evade tax, he shall serve notice on the person chargeable with tax which has not been so paid or which has been so short paid or to whom the refund has erroneously been made, or who has wrongly availed or utilized input tax credit, requiring him to shour cause as to why he should not pay the amount specified in the notice along with interest payable thereon under section 50 and a penalty equivalent to the tax specified in the notice."

📝 .6 Interest on delayed payment of tax

Section 50(1) Every person who is liable to pay tax in accordance with the provisions of this Act or the rules made thereunder, but fails to pay the tax or any part thereof to the Government within the period prescribed, shall for the period for which the tax or any part thereof remains unpaid, pay, on his own, interest at such rate, not exceeding eighteer per cent., as may be notified by the Government on the recommendations of the Council.

Take per Section 20 of the IGST Act, 2017:

Section 20. Subject to the provisions of this Act and the rules mule thereunder, the provisions of Central Goods and Services Tax Activelating to,

(i) scope of supply;(ii) composite supply and mixed supply;(iii) time and value of supply;(iv) input tax credit;(v) regisfration;(vi) tax invoice, credit and debit notes;(vii) accounts and records;(viii) returns, other than late fee;(ix) payment of tax;(x) to a deduction of source;(xi) collection of tax at source;(xii) as sessment;(xiii) refunds;(xiv) audit;(xv)inspection, search, seizure and arrest;(xvii) demands and recovery;(xvii)liability to pay in certain cases;(xviii) advance ruling;(xix) appeals and revision;(xx) presumption as to documents;(xxi) offences and penalties;(xxii) job work;(xxiii) electronic commerce;(xxiv) transitional provisions; and(xxv) miscellaneous provisions including the provisions relating to the imposition of interest and penalty. shall, mutatis mutandis, apply, so far as may be, in relation to integrated tax as they apply in relation to central tax as if they are enacted under this Act."

8. CONTRAVENTION OF VARIOUS PROVISIONS:

- 8.1 From the foregoing paras, it appeared that M/s Manji had contravened thefollowing provisions of the CGST Act, 2017 and Rules made thereunder and the provisions of IGST Act, 2017:
 - (i) Section 54 of the CGST Act, 2017 along with the corresponding entry of the Gujarat State Goods and Services Act, 2017 read with the provisions of Section 20 of Integrated Goods and Service Tax Act, 2017 in as much as they had fraudulently claimed the refund of IGST paid on export of Goods
 - (ii) Section 16 of the IGST Act, 2017 in as much as they had fraudulently claimed the refund of IGST without being eligible for the same.
 - (iii)Rule 96 of the CGST Rules, 2017along with the corresponding entry of the Gujarat State Goods and Services Act, 2017 read with the provisions of Section 20 of Integrated Goods and Service Tax Act, 2017 in as much as they had availed the benefit of said rule although they were not eligible for the same in light of conditions laid down in Rule 96(10) of the CGST Rules, 2017.
 - (iv) Section 39(7) & 39(9) of the Central Goods and Services Tax Act, 2017 along with the corresponding entry of the Gujarat State Goods and Services Act, 2017 read with the provisions of Section 20 of Integrated Goods and Service Tax Act, 2017 in as much as they had failed to pay to the Government the tax due as per such return not later than the last date on which he is required to furnish such return.
- 9.1 It is pertinent to mention here that the system of self-assessment is specifically incorporated in respect of GST under the provisions of Section 59 of CGST Act' 2017 /Gujarat GST Act'2017 which reads as "59. Every registered person shall self-assess the taxes payable under this Act and furnish a return for the tax period as specified under section 39". It appeared that the saids to taxpayer had suppressed wrong availment of refund as discussed hereing above and thereby it appeared that they had knowingly failed to correctly self-assess.

tax payable with an intent to evade payment of proper tax. In the scheme of self-assessment, the department comes to know about the supplies made and tax paid during the scrutiny of the statutory returns filed by the taxpayers under the statute. Therefore, it places greater onus on the taxpayer to comply with standards of disclosure of information in the statutory returns.

9.2. Explanation 2 to Section 74 of the CGST 2017 has defined suppression as under:

"Explantition 2.-For the purposes of this Act, the expression "suppression" shall man non-declaration of facts or information which a taxable person is required to declare in the return, statement, report or any other document furnished under this Act or the rules made thereunder, or failure to furnish any information on being asked for, in writing, by the proper officer.

- From the Information/ data provided under DGARM Report No.49D as well as from the failure of the taxpayer in furnishing the required information despite repeated reminders given by the department, it appeared that M/s. Manji had suppressed the erroneous refund of IGST paid on exports and their tax liabilities had not been discharged properly. The failure to properly discharge the Tax liability is utter disregard to the requirements of law and breach of trust deposed on them, is outright act in defiance of law by way suppression, concealment & non-furnishing value of erroneous refund with intent to evale payment of tax. The above said erroneous refund of IGST availed/taken on exports, was unearthed after investigation was conducted by officers of Catral Tax, Ahmedabad North in pursuance of DGARM Report No.49D and therefore had the investigation not been initiated by the department, the said facts would have not come to light. All the above facts of contravention on the part of the Taxpayer have been committed with an Sintention to evade the payment of tax by suppressing the facts. Therefore, the same is required to be demanded from them under Section 74(1) of the CGST Act, 2017/Gujarat GST Act, 2017 read with Section 20 of IGST Act, 2017 by invoking extended period of five years. Since M/s. Manji were liable to selfassess the liability to pay tax, they had an obligation to furnish the correct and complete information.
- 9.4. Further it appeared that M/s. Manji had not paid the tax within the prescribed die dates and also refund of IGST had been availed/taken erroneously. These non-payments of Tax had not been shown in their statutory GST returns. It, therefore, appeared that there was a case of suppression of facts with intent to evade the payment of tax. It appeared that short paid/ not paid IGST was to be demanded/ recovered from the said taxpayer under the provisions of Section 74(1) of the CGST Act' 2017 read with the provisions of Section 20 of the IGST Act, 2017.

Further, CBI issued Notification No. 13/2022-Central Tax dated 05.07.2022 vide which time limits prescribed under Sec. 73(9) & 73(10) was extended and reads as under

extends the time limit specified under sub-section (10) of section 73 for issuance of order under subsection (9) of section 73 of the said Act, for lecovery of tax not paid or short paid or of input tax credit wrongly availed for utilized in respect of a tax period for the financial year 2017-18, up to the 30th day of September, 2023;

(ii) excludes the period from the 1stday of March, 2020 to the 28th day of February, 2022 for computation of period of limitation under sub-section (10) of section 73 of the said Act for issuance of order under subsection (9) of section 73 of the said Act, for recovery of erroneous refund (iii) excludes the period from the 1 st day of March, 2020 to the 28th day of February, 2022 for computation of period of limitation for filing refund application under section 54 or section 55 of the said Act."

Further, H'ble Supreme Court in matter of Re: Cognizance for Extension of Limitation [Miscellaneous Application No. 21 of 2022 in miscellaneous Application No.665 of 2021 in suo moto writ petition (C) NO. 3 of 2020 dated 10 Jan 2022]revived limitation extension order till Feb 28, 2022, vide order dated 10.01.2022. Hon'ble Supreme Court pronounced that:

"We deem it appropriate to dispose of the M.A. No. 21 of 2022 with the following directions: -

- "1. "The order dated 23.03.2020 is restored and in continuation of the subsequent orders dated 08.03.2021, 27.04.2021 and 23.09.2021, it is directed that the period from 15.03.2020 till 28.02.2022 shall stand excluded for the purposes of limitation as may be prescribed under any general or special laws in respect of all judicial or quasi-judicial proceedings.
- II. Consequently, the balance period of limitation remaining as on 03.10.2021, if any, shall become available with effect from 01.03.2022."
- 9.5. In view of the above facts, the erroneously refunded amount of Rs.4,48,00,000/- was liable to be recovered from them under Section 74(1) of the CGST Act, 2017 read with Section 20 of the IGST Act, 2017 and the Rules made there under along with interest as applicable under Section 50(1) of the said Act and the Rules made there under. Further, by such acts of omission and commission, the Taxpayer appeared have also rendered themselves liable for penal action under Section 74(1) of CGST Act, 2017 for congravention of provision of CGST Act, 2017 /IGST Act, 2017 and rules made thereunder. Further, they also appear to be liable for penal action under Section 122(1)(xvii) of CGST Act, 2017 for their failure in furnishing the required information despite repeated reminders/correspondence made by the department in this regard.
- 9.6. Further, Form GST DRC-01A regarding intimation of tax ascertained as being payable under Section 74(5) of CGST Act, 2017 before issuing of Show Cause Notice was issued to the taxpayer on 18.09.2023, however, till date of issuance of Show Cause Notice, this office had not received any response from the taxpayer.
- 10. Therefore, a Show Cause Notice F.No. GST/15-60/OA/23-24 dated 27.09.2023 was issued to M/s. Manji Kalyanji Vekariya, having their principal place of business at A-2, Rahul Apartment, Naranpura Gam, Naranpura, Ahmedabad, Gujarat-380013, by the Joint Commissioner, CGST, Ahmedabad North, calling upon them to show cause as to why:-
 - (i) The erroneously refunded IGST amount of Rs. 4,48,00,000/-(Rs. Crores Forty Eight Lacs only) should not be demanded and red from them under Section 74(1) of the Central Goods & Service 74 2017 read with Section 20 of the IGST Act, 2017;

- (ii) Interest the appropriate rate should not be demanded and recovered from the proposed demand mentioned at (i) above, under the provisions of Section 50(1) of the Central Goods & Service Tax Act, 2017 read with Section 20 of the IGST Act, 2017;
- (iii)Penalty should not be imposed upon them on the proposed demand at (i) with Section 74(1) of the CGST Act, 2017 read with correspond ing Section of Gujarat GST Act, 2017 read with Section 20 of the IGST Act, 2017;&
- (iv) Penalty should not be imposed upon them under Section 122(1)(xvii) of CGST Act 2017.

DEFENSE REPLY:-

- 11.1 M/s. Manji had filed a reply dated 27.10.2023 and 08.03.2024, wherein, they furnished the following details:-
 - Annexur containing details of export invoices and details of purchases shipping bill-wise.

 - GSTR-2/form.
 Export bill in respect of which IGST refund was claimed.
 - Annual (STR-1 and GSTR-3B returns.
- 11.2. M/s. Manji stated that they have claimed refund of Rs.30,37,892/- in respect of goods exported by them, however, they had received SCN wherein it has been men ioned that they had claimed refund of Rs.4,48,00,000/-, which incorrect.
 - 1.3. They stated that they had claimed refund according to the rule 96(10) of the CGST Rules, 2017.

PERSONAL HEARING

Adhering to the principal of natural justice, personal hearing was provided to M Manji on 29.02.2024. Shri Manji Kalyanji Vekariya, Proprietor M/s. Vrundav in International, appeared for personal hearing. He re-iterated vritten submission dated nil on 27.10.2023. Further, he requested time till 07.03.2024 for submission of additional details. He further requested to decide the SCN on medits.

DISCUSSION AND FINDINGS

- I have callefully gone through the records of the case, defense reply dated 27.10.2023 and 08.03.2024 and submission made by them during the course of personal hearing and proceed to decide the case. As per the details provided by M/s. Manji they had paid IGST of Rs.30,37,892/- on goods exported by them, i.e. refund claimed by them on goods exported on payment of IGST, during the period from July 2017 to March 2022. Further, they also provided Export Invoice, Shipping Bill, GSTR-2A, Annual GSTR-1 and GSTR-3B returns.
- It is alleged in the SCN that M/s. Manji had received refund of IGST sunting to 3 4,48,00,000/- paid on exports (Zero Rated Supplies) made taring period from 23.10.2017 to 31.03.2022. The moot point to be decided is as to whether the noticee had violated any of the provisions of Rule 96(10) of WESGGST Rules 2017 or otherwise and the refund of IGST paid on the ported goods serroneous or not.

- 15. Before taking into consideration the submission made by the noticee firstly I reiterate the legal provisions related to Rule 96(10) of the CGST Rules. I have noted that Section 54 of the CGST Act, 2017 deals with the provisions related to refund, which also includes refund of tax paid on zero rated supplies of goods or services or both. Zero rated supplies have been defined in Section 16 (1) of the IGST Act, 2017 as (a) export of goods or services of both and, (b) supply of goods or services or both to a SEZ developer or a SEZ unit. I have also noted that Section 16(3) of the IGST Act, 2017 provides for a registered person making zero rated supplies to claim refund under the following two options:-
 - (i) supply of goods or services or both under LUT without payment of IGST and claim refund of unutilized input tax credit.
 - (ii) supply of goods or services or both on payment of IGST and claim refund on goods or services or both on payment of IGST.
- 16. Rule 96(10) of the CGST Rules, 2017 makes an exception in respect of refund of IGST paid during the export of goods on which certain benefits have been availed by exporter. The relevant portion of Rule 96(10) is reproduced below:-
 - "(10) **The persons** claiming refund of integrated tax paid on exports of goods or services **should not have** –
 - (a) received supplies on which the benefit of the Government of India, Ministry of Finance notification No. 48/2017-Central Tax, dated the 18th October, 2017, published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (i), vide number G.S.R 1305 I, dated the 18th October, 2017 except so far it relates to receipt of capital goods by such person against Export Promotion Capital Goods Scheme or notification No. 40/2017Central Tax (Rate), dated the 23rd October, 2017, published in the Gazette of India Extraordinary, Part II, Section 3, Sub-section (i), vide number G.S.R 1320 I, dated the 23rd October, 2017 or notification No. 41/2017-Integrated Tax (Rate), dated the 23rd October, 2017, published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (i), vide number G.S.R 1321 I, dated the 23 October, 2017 has been availed; or
 - (b) availed the benefit under notification No.78/2017-Custor is, dated the 13th October, 2017, published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (i), vide number G.S.R 1272I, dated the 13th October, 2017 or notification No. 79/2017-Customs, dated the 13th October, 2017, published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (i), vide number G.S.R 1299 I, dated the 13th October, 2017 except so far it relates to receipt of capital goods by such person against Export Promotion Capital Goods Scheme."
- 17. Further, as per Rule 96(1) of the CGST Rules, 2017, the shipping bill filed by the exporter of goods shall be deemed to be an application for refund of IGST paid on the exported goods if both the departure manifest or export manifest or export report covering the number and date of shipping bill, and a valid return in GSTR 3B is filed.
- 18. The procedure regarding claiming of refund is prescribed in Rule 89(1) of the CGST Rules, 2017, wherein a refund claim in Form RFD-01 has to be first and the However, this procedure is not applicable for refund of integrated tax paid in goods exported out of India, which are dealt with separately in Rule 96 figure CGST Rules, 2017. For refund of IGST paid on goods exported out of India; as

mentioned sure, the shipping bill itself is deemed to be an application for refund. In such cases, the IGST module has an inbuilt mechanism to automatically grant refund after validating the shipping bill data available in ICES against the GST returns data transmitted by GSTN. If the necessary matching is successful, ICES processes the claim for refund and the respective amount of IGST paid with respect to each shipping bill is electronically credited to the exporter is bank account. Thus, in terms of the restriction imposed under Rule 9 (10) of the CGST Rules, the exporter ought to have exported the goods under IUT instead of payment of IGST because once the export is made under payment of IGST, the filing of the shipping bill is treated as filing of refund claim at mentioned in Rule 96(1) of the CGST Rules, 2017 and the claim gets automatically processed by ICES without any manual intervention from the Customs authorities. Rule 96(10), thus, in essence, bars the payment of IGST luring the export of goods where the benefit of notifications specified in the rule is availed.

18.1. This restriction was first introduced vide Notification No. 03/2018-Central Tax diffed 23.01.2018, which got subsequently modified and amended by way of Notifications issued from time to time (as discussed below).

Notification No. 03/201 8-Central Tax dated 23.01.2018 reads as:(x) with effect from 23rd October, 2017, in rule 96,

"(10) The persons claiming refund of integrated tax paid on exports of goods or services should not have received supplies on which the supplier has availed the benefit of the Government of India, Ministry of Finance, notification No. 48/2017 Central dated the 18th October, 2017 published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (i), vide number G.S.R 1305 (E) dated the 18th October, 2017 or notification No. 40/2017-Central Tax (Rate) 23rd October, 2017 published in the Gazette of India, Extraordinary, Part II, Section, 3 Sub-sectinii (i), vide number G.S.R 1320 (E) dated the 23rd October, 2017 or any notification No. 41/2017-Integrated Tax (Rate) dated the 23rd October, 20)7 published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (i), vide number G.S.R 1321 (E) dated the 23rd October, 2017 or notification No, 78/2017 Customs dated the 13th October, 2017 published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (i), vide number G.S.R 1272(E) dated the 18th October, 2017 or notification No. 79/2017-Customs dated the 13th October, 2017 published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (i), vide number G.S.R 1299 (E) dated the 13th October, 2017."

The above notification says that person claiming refund of IGST paid on exports of goods or services should not have received supplies on which the supplier has availed the benefit of Notifications as mentioned therein.

8.2. Vide Notification No. 39/2018-Central Tax dated 04.09.2018, the said Rule 96(10) of GST Rules, 2017 was further amended as below:

"6.In the said rules, with effect from the 23rd October, 2017, in rule 96, for sub-rule (10), the following sub-rule shall be substituted, namely:-

(10) The persons claiming refund of integrated tax paid on exports of goods or services should not have –

or services should not have —

(a) received supplies on which the benefit of the Government of India, Ministry of finance notification No. 48/2017-Central Tax, dated the 18th October, 2017 published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (i), vide number G.S.R 1305 (E), dated the 18th October, 2017 or notification No. 40/2017 Central Tax (Rate), dated the 23rd October, 2017 published in the

Gazette of India, Extraordinary, Part II, Section 3, Sub-section (i), vide number G.S.R 1320 (E), dated the 23rd October, 2017 or notification No. 41/2017-Integrated Tax (Rate), dated the 23rd October, 2017 published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (i), vide number G.S.R 1321 (E), dated the 23rd October, 2017 has been availed; or

- (b) availed the benefit under notification No. 78/2017-Customs, dated the 13th October, 2017 published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (i), vide number G.S.R 1272(E), dated the 13th October, 2017 or notification No. 79/2017-Customs, dated the 13th October, 2017 published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (i), vide number G.S.R 1299 (E), dated the 13th October, 2017."
- 18.3. Thus, from the perusal of above notification, it can be construed that refund on exports cannot be availed by the exporter if the inputs procured by them have enjoyed benefits of certain notifications mentioned therein, i.e. in the Rule 96(10). Further, vide Notification No. 53/2018-Central Tax dated 09.10.2018, the Rule 96(10) was further amended with effect from 23.10.2017 which reads as:-
 - "1. (1) These rules may be called the Central Goods and Services Tax (Eleventh Amendment) Rules, 2018.
 - (2) They shall be deemed to have come into force with effect from the 23rd October, 2017.
 - 2. In the Central Goods and Services Tax Rules, 2017, in rule 96, for sub-rule (10), the following sub-rule shall be substituted and shall be deemed to have been substituted with effect from the 23rd October, 2017, namely:-
 - "(10) The persons claiming refund of integrated tax paid on exports of goods or services should not have received supplies on which the supplier has availed the benefit of the Government of India, Ministry of Finance, notification No. 48/2017-Central Tax, dated the 18th October, 2017, published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (i), vide number GS.R 1305 (E), dated the 18th October, 2017 or notification No. 40/2017-Central Tax (Rate) dated the 23rd October, 2017, published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (i), vide number G.S.R 1320 (E), dated the 23rd October, 2017 or notification No. 41/2017-Integrated Tax (Rate), dated the 23rd October, 2017, published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (i), vide number G.S.R 1321 (E), dated the 23rd October, 2017 or notification No. 78/2017-Customs, dated the 13th October, 2017, published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (i) vide numbers G.S.R 1272(E), dated the 13th October, 2017 or notification No. 79/2017 Customs, dated the 13th October, 2017, published in the Gazette of India; Extraordinary, Part II, Section 3, Sub-section (i), vide number G.S.R (1299 (E) dated the 13th October, 2017.".

Thus, from the perusal of above notification, it can be obserted that subclause (a) and (b) of sub-rule 10 of Rule 96 are merged and this notification is also made effective from 23.10.2017. It says that person claiming refund of IGST paid on exports of goods or services should not have received supplies, on which the supplier has availed the benefit of Notifications as mentioned therein.

18.4. The subject matter pertaining to Rule 96 (10) of CGST Rules, 2017 was at the further amended by the issuance of Notification No. 54/2018-Central Tax databases 09.10.2018 and an exception was carved from the restriction imposed by said

rule 96(10) Rule 96 for those exporters who are importing capital goods under the EPGG Scheme. This notification was made effective from the date of publication in the Official Gazette i.e. 09.10.2018. The said Notification reads as:-

"(10) The persons claiming refund of integrated tax paid on exports of goods or services should not have –

(a) received supplies on which the benefit of the Government of India, Ministry of Finance of offication No. 48/2017-Central Tax, dated the 18th October, 2017, published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (i), vide number G.S.R 1305 (E), dated the 18th October, 2017 except so far it relates to receipt of capital goods by such person against Export Promotion Capital Goods Scheme in notification No. 40/2017-Central Tax (Rate), dated the 23rd October, 2017, published in the Gazette of India, Extraordinary, Part II, Section 3, Subsection (vide number G.S.R 1320 (E), dated the 23rd October, 2017 or notification No. 41/2017-Integrated Tax (Rate), dated the 23rd October, 2017, published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (i), vide number G.S.R 1321 (E), dated the 23rd October, 2017 has been availed; or

(b) availed the benefit under notification No. 78/2017-Customs, dated the 13th October, \$017, published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (i), vide number G.S.R 1272(E), dated the 13th October, 2017 or notification No. 79/2017-Customs, dated the 13th October, 2017, published in the Gazette India, Extraordinary, Part II, Section 3, Sub-section (i), vide number G.S.R 12 9 E), dated the 13th October, 2017 except so far it relates to receipt of capital goods by such person against Export Promotion Capital Goods Scheme.".

As per the records of the case, the department had received an DGARM report that M/s. Manji had availed erroneous refund of Rs. 4,48,00,000/- on goods exported with payment of IGST and had also availed benefits of motifications specified in Rule 96(10) of the CGST Rules, 2017. Thus, they had violated the provisions of Rule 96(10) of the CGST Rules. As a result of which, the SCN was issued for the period 23.10.2017 to 31.03.2022 for the total amount of IGST of Rs. 4,48,00,000/- paid on the exported goods in contravention of Rule 96(10) of the CGST Rules, 2017. I find that the amount of refund was arrived at on the basis of DGARM report, however, M/s. Manji have challenged the said amount and provided supporting documents in this regard viz. GSTR-1 and GSTR-3B Annual Return summary, Shipping Bills and Export Invoices: Accordingly, to arrive at correct amount of refund of IGST paid on exported goods, I consider the amount of IGST paid on zero rated supplies shown in GSTR-3B Returns for the concerned period. As per the GSTR-3B Returns, M/s. Manji have paid IGST of Rs. 30,37,892/- on Zero Rated Supplies, which matches with the details provided by M/s. Manji. Accordingly, I consider this as the amount of refund availed by M/s. Manji during the period from October 2017 March 2022 and proceed to decide the issue on the basis of material available on record and on merits.

Firstly, Fir have stated that they have not claimed refund in accordance with the provisions of Rule 96(10) of the CGST Rules, 2017. They provided details of them on payment of IGST and goods purchased against such find that M/s. Manji have procured goods domestically. Accordingly, needs to be examined as to whether they have availed benefit of Notification 2017 Central Tax, dated the 18th October, 2017 or Notification 0/2017-CE(R) or 41/2017-IT(R) both dated 23.10.2017 in respect of

purchases made pertaining to the exports made on payment of IGST, i.e. where refund of IGST paid on export was claimed by them. I find that as per the details given by them, all the purchases in respect of goods exported by them were made on payment of applicable tax and not at concessional rates prescribed vide the above notifications. I also find that the invoices specified by M/s. Manji are also reflected in GSTR-2A, wherein applicable rate has been charged by the supplier.

- 21. Rule 96(10) specifies that persons claiming refund of integrated tax paid on exports of goods or services should not have availed benefit of Notification No. 48/2017-Central Tax, dated the 18th October, 2017 of Notification No.40/2017-CT(R) or 41/2017-IT(R) both dated 23.10.2017 or patification No. 78/2017-Customs or 79/2017-Customs, both dated the 13th October, 2017. It a person avails benefit of these notifications for their inward supplies, they are not eligible to claim refund in respect of IGST paid on export of goods as per the provisions of Rule 96(10) of the CGST Rules, 2017. In the present case, M/s. Manji have not availed benefit of these notifications and accordingly, refund availed by them is not restricted in accordance with the provisions of Rule 96(10) of the CGST Rules, 2017. Accordingly, I find that they have claimed refund in accordance with the provisions of Rule 96(10) of the CGST Rules, 2017. Hence, I am not inclined to confirm the demand of erroneous refund as proposed in the Show Cause Notice issued to M/s. Manji.
- 22. There is no question of erroneous refund in the present case, therefore, question of interest under Section 50 of the CGST Act, 2017 does not arise. Further, penalty under Section 74 can only be imposed when any tax has not been paid or short paid or erroneously refunded or where input ax credit has been wrongly availed or utilised by reason of fraud, or any wilful misstatement or suppression of facts to evade tax. In the present case, M/s. Manji have not availed any erroneous refund. Accordingly, penalty under Section 74 cannot be imposed. Accordingly, I do not intend to impose penalty on M/s. Manji.
- 23. I find that the taxpayer were asked to provide documents pertaining to exports done by them and benefits availed by them vide etters dated 28.03.2023 and 20.04.2023 by the Jurisdictional Authorities, however, they did not provide the required details/documents. Accordingly, it has been proposed to impose penalty under Section 122(1)(xvii) in the Shoe Gause Notice. However, during the course of proceedings, M/s. Manji provided all the requisite documents. Accordingly, I do not intend to impose penalty under the said section.
- 24. In view of the above discussion and findings, I pass the following order:-

ORDER

- (i) I drop the demand of IGST refund amounting to Rs. 448,00,000/(Rupees Four Crore Forty Eight Lakh Only) Section 74(1) of the CGST
 Act, 2017 and the corresponding entry of the Gujarat State Goods and
 Services Tax Act, 2017 and Section 20 of the Integrated Goods and
 Service Tax Act, 2017;
- (ii) I do not order to demand interest from them under the provision Section 50(1) of the CGST Act, 2017 and the corresponding entry of Gujarat State Goods and Services Tax Act, 2017 and Section 20 to

Integrated Goods and Service Tax Act, 2017;

- (iii) I do no impose a penalty under Section 74(1) of the CGST Act, 2017 read with the Section 74(1) of the Gujarat GST Act, 2017 read with Section 20 of IGST Act, 2017;
- (iv) I do not impose penalty under Section 122(1)(xvii) of the CGST Act, 2017 read with the Section 122(1)(xvii) of the Gujarat GST Act, 2017 read with Section 20 of IGST Act, 2017 on M/s. Manji Kalyanji Vekariya.

25. Accordingly the Show Cause Notice No. Show Cause Notice No.- GST/15-60/OA/23-24 dated 27.09.2023 is disposed off.
